Sloop requested an increase for Wm Hulver SL-6. Contract # 13-15-0086; Instance #204237 in the amount of \$18,648.90.

Motion made to approve the increase for Contract #13-15-0086. (Hockman-Nicholas; Childs, motion passed).

Gochenour submitted an Equipment Tax Credit for Jonathan Church.

Motion made to approve the tax credit. (Comanor, Hockman-Nicholas, motion passed).

Dam Safety Committee: Fagan reported that they had some wind damage to the auto control gate at Bryce.

Education & Information Committee: Comanor reported that the Area I Meeting Agenda is in the folders. The new education coordinator will begin the first week of May. She gave a County Farm update. We are finalizing arrangements for the November 2018 awards luncheon. Minutes from the March 8th Ed & Info Committee are attached. The committee will meet immediately following the May 10 Board meeting.

Finance Committee: Martin reported that HB Simpson was not in attendance. They are working on establishing 2019 budget. Committee Chairs should send him their budget requests. The committee also approved a request to authorize the expenditure of funds for a second vehicle for the district, as well as, the replacement of one staff computer.
